In 2010 the promoters applied for and were granted approval by the Federal Ministry of Education to operate a business school in the new name

ISM Lagos prides herself on the network of established strategic and academic partnerships with international academic and professional institutions across the globe. One of such of valuable partners is the Laureate Online Education Netherlands which is a network of over ffty fully accredited and prestigious universities across America and Europe including the University of Liverpool in England, Walden University in the US, Glion Institute of Higher Education in Switzerland and Roehampton University London. Another is the Resource Development International (RDI) UK which is a platform of six highly ranked UK universities offering long distance education for more than two decades. RDI UK is a university level degree awarding institution in the UK.

ISM Lagos also offers a suite of affordable degree programmes up to masters and doctoral levels in partnership with Amity University, which is ranked by the QS as one of the topmost private universities in the whole of Asia.

ISM Lagos currently pioneers the deployment of an intercampus online academic learning and professional development platform called Online Campus Nigeria – OCN (www.onlinecampus.edu.ng) that hosts millions of students and lecturers concurrently from different Nigerian universities and corporate organizations. The OCN portal is supported with well researched study materials and efficient pedagogy.

Globally the campaign on academic integrity has become a major topic of discussion and projects; ISM Lagos through its Centre for Academic Integrity Research and Anti-plagiarism (CAIRA) is happy to associate with the committee of Vice Chancellors of Nigerian Universities along with their other African counterparts in achieving their noble objectives of a social transformation that emanates from within the academic institutions through the teaching of academic integrity and ant plagiarism guidelines across institutions.

The business school also collaborates with private and public organisations through her quarterly programme "Critical Action Research Series (CARS)" in conducting regular management and organisational development research studies of various themes designed to provide valuable information for the professionals while guiding the theoreticians in the conduct of practice relevant studies.

ISM Lagos works extensively in the area of quality and assurance in the delivery and management of education; currently partnering with the Global Ties US in providing contacts and fellowships for the teaching service commissions (TESCOM) and Ministries of Education of some states in Nigeria to enable them integrate with and learn from the systems and practices of the US Department of Education.
